

Admittedly, these two OAs are similar in all respects to that of OA 2226/95, OA 1975/95 and OA 1880/95 which have been disposed of by this Tribunal by decision dated 26.7.96 (copy placed on record.)

We note from the perusal of the application that the applicant has himself relied on OA 2226/95 and OA 1880/95 and that the issues in these cases are similar.

In the light of the above observations, we also dispose of these OA 1152/95 and 1153/96 by a common order. For the reasons given in OA 2226/95 and connected cases, these applications are dismissed. No order as to costs.


