This OA has been filed by the applicants aggrieved by the order of termination of services claiming various reliefs including directions to respondents to appoint the applicants on regular basis and regularise their services as Worked Charged Khalasis and other consequential benefits.

2. The respondents in the reply have raised an objection on the maintainability of this OA on the ground that similar reliefs have been agitated in OA.No.1300/94 before the Hon'ble Bench of the Tribunal.


3. I have heard the learned counsel of both sides. The learned counsel for the applicants

submitted that some similarly circumstanced employees ranked juniors to the applicants approached the Guwahati Bench of the Tribunal when their services were terminated and obtained a direction that they shall not be disengaged, and in terms of that direction, the applicants would seek a similar direction and they ^{have} approached this Tribunal for similar orders.

4. The learned counsel for the respondents states that in pursuance of the directions given by the Hon'ble Bench in OA.1300/94, the respondents are already taking steps to prepare a scheme and the matter is pending approval of the Cabinet. In so far as the present applicants are concerned, the respondents would be willing to consider them ^a ~~in matter~~ subject to availability of work in preference to the outsiders. ^{Accordingly, or} Considering relief b), this OA is disposed of at the admission stage itself with a direction that the applicants will be offered work, if available, in preference to outsiders and juniors in accordance with their seniority. No costs.
