ORDER (ORAL)

By Mr. Justice V.Rajagopala Reddy,

Heard counsel for the applicants and the
respondents. Reply is filed to MA-1675/2000.

2. It is stated that a tripartite agreement
between DTS, DTO and TTS has been reached on the issued
of merger in the proceedings dated 16.8.2000 and in
pursuance of this agreement in the proceedings dated
16.8.2000 the Government had implemented the conditions
in that agreement. The parties in this case, therefore,
submit that in view of the above, nothing survives in the
OA. The OA is, therefore, dismissed as infructuous. It
is made clear that if the respondents had committed
breach of the conditions in the tripartite agreement it
is open to the applicants to approach the Tribunal to
enforce the agreement. MA-2041/2000 and 1675/2000 is also
disposed of.
