### O R D E R

CHETTUR SANKARAN NAIR(J), CHAIRMAN.

Applicants complain that parity has not been maintained in the matter of salary viz-a-viz themselves and other similarly situated teachers. We have heard learned counsel appearing for respondents. The impugned orders (for example A-1 in OA 2298/96) does not reveal the reason behind the rejection. In spite of the persuasive submissions of counsel for respondents we are unable to sustain the orders. We quash them and direct respondents to pass a speaking order comparing the case of applicants with those whose cases are pointed out as comparable by applicants, and communicate the same to applicants within two months from today. Respondents will do well to adhere to the time limit.

Applications are disposed of as aforesaid.
