Shri Justice K. M. Agarwal -

Learned counsel for the applicant submitted that as per his information, the applicant has been regularised pursuant to the order of the Tribunal. However, the counsel for respondents submitted that only a proposal was made for regularisation and procedural formalities have to be completed.

2. Be that as it may, the compliance appears to have been done substantially and even the applicants admit that the order has been complied with.

3. Under the circumstances, these contempt proceedings are dropped. Rule nisi shall stand discharged. Formalities, we hope, shall be completed within three months. This time is granted as requested by the learned counsel for respondents. Therefore, we hope no further time will be taken for completing the formalities.
