ORDER

S.R. ADIGE, VC(A):

These OAs are being disposed of by this  
common order.

2. Heard both sides.
3. Admittedly pursuant to the Tribunal's order dated 23.1.95 in OA No.1992/90, 27 applicants in that OA were given certain benefits vide respondents' order dated 13.3.96, which applicants in the present OAs, are now claiming on account of being senior to them or similarly placed as them. Respondents have taken the view that the benefits were granted by their order dated 13.3.96 through admn. error, and it is not denied that notices have been issued to those applicants to show cause why those benefits should not be withdrawn. Those applicants had approached the Tribunal against those show cause notices, and it is not denied that further action on those show cause notices has been stayed by the Delhi High Court.
4. Under the circumstances, we dispose of these OAs giving liberty to parties to seek revival of the same after the Delhi High Court passes final orders on the show cause notices issued by respondents, in
