O R D E R (ORAL)

Shri Justice Ashok Agarwal :

It is undisputed that the applicants in the present O.As. are similarly placed to the applicants in O.A. No.357/95 of Jaipur Bench. As far as the applicants before the Jaipur Bench are concerned, by a judgment and order passed on 25.11.1999 reliefs claimed by the applicants <sup>herein</sup> have been granted. Applicants in the present O.As. <sup>as also the aforesaid O.A.</sup> had joined as Data Entry Operators Grade-B in the Department of Census, Government of India. The Fourth Pay Commission, recommendations ~~of~~ which came into force w.e.f. 1.1.1986, had suggested that Data Entry Operators Grade-B in the office of Registrar General, India may be given the pay scale of Rs.1200-2040. The Government of India appointed Sheshagiri Committee to look into the grievances in relation to pay scales of Data Entry Operators performing the same work in Railways and other departments under the Government of

India. The said Committee found that the nature of duties and responsibilities attached to the Data Entry Operators Grade-B was identical in all departments and there was no difference in their qualifications and duties and, therefore, recommended that the pay scale of Rs.1350-2200 be extended to them also. The Department of Census extended the same but only with effect from 11.9.1989 and not from 1.1.1986. Following this, a series of cases were filed in various Benches of the Tribunal. One such O.A. is the aforesaid O.A. No.357/95 (Jaipur Bench). By the order passed on 25.11.1999 a direction has been issued to the respondents to extend the pay scale of Rs.1350-2200 to the applicants therein w.e.f. 1.1.1986 and also to pay the arrears to which the applicants had become so entitled. In our view, since the applicants in the present case are identically placed to the applicants in the aforesaid O.A., the only course open to us in the present O.A. is to grant a relief similar to the one granted in the aforesaid O.A. by the Jaipur Bench.

2. Shri Gangwani, the learned counsel appearing for respondents, however, placing reliance on a decision of this Tribunal in the case of Y. D. Sharma & Ors. v. Union of India & Ors., O.A. No.2346A/95 (Principal Bench) decided on 18.11.1999, has sought to contend that it is open to the Government to fix different dates for the purpose of granting the increased pay scale which is prescribed by the Government.

proposition of law, the applicants in the present case cannot be differentiated from the applicants before the Jaipur Bench. The relief which has been granted by the Jaipur Bench to the applicants before it will be available to all Data Entry Operators in the Department of Census.

4. In the circumstances, the present O.As. are allowed. We direct the respondents to extend the pay scale of Rs.1350-2200 to the applicants in the present O.As. with effect from 1.1.1986 and also to pay the arrears to which the applicants have become so entitled. This exercise may be completed expeditiously and preferably within a period of four months from the date of receipt of a copy of this order. There shall, however, be no order as to costs.
