ORDER

S.R. Adige, VC(A):

These 4 OAs had been placed before Full Bench which  
had been constituted to answer the following reference

- (A) Whether in the circumstances of the case the  
reference to a Full Bench is warranted?
- (B) Whether the applicant's claim for a direction  
to the respondents to include the 'S' grade  
service of ARS or equivalent grades for  
computation of the total length of service  
for purposes of not only placement on the  
revised pay scale under the UGC pay package  
by the ICAR by Notification dated 9.3.89 but  
also for purposes of promotion of Scientists,  
Senior Scale, Selection Grade/Sr. Scientists,  
under the Career Advancement Scheme notified  
on 28.10.91 is justified?

2. The reference was answered as under:

- (A) Yes.
- (B) Applicants would be entitled to include their 'S' grade of ARS or equivalent grade for computation of the total length of service only for purpose of placement in the revised pay scale under the UGC pay package notified by ICAR on 9.3.89 but would not be entitled to include the said service for the purpose of promotion of Scientists, Senior Scale, Selection Grade, Senior Scientists under the Career Advancement Scheme notified on 28.10.91.

3. The four OAs were accordingly directed to be placed before this Bench, namely our Bench which made the reference, for disposal in accordance with law, in the light of the aforesaid decision of the Full Bench.

4. We have heard Shri M.K.Dua for the applicants and Shri V.K.Rao for respondents.

5. Shri Dua has contended that in the light of the aforesaid orders of the Full Bench, applicants in OA No.399/97 and No.402/97 are entitled for inclusion of their 'S' grade of ARS or its equivalent grade for computation of total length of their service, for what he terms the "purpose of placement". Written submissions have also been made to this effect. Whether it is placement in the revised pay package alone, or

under the Career Advancement Scheme notified on 28.10.91 has not been made explicit, but the fact that the placement sought is under the Career Advancement Scheme is evident from para 7 of the written submissions.

6. These contentions are opposed by Shri V.K. Rao who asserts that in terms of Full Bench' decision, the service put in by applicants in 'S' grade of ARS or its equivalent grade can be included for computation of total length of their service for purpose of placement in the revised pay scale under the UGC pay package notified by ICAR on 9.3.89 and cannot be included for the purpose of Scientists, Senior scale, Selection Grade, Senior Scientists under the Career Advancement Scheme notified on 28.10.91.

7. It is clear that in terms of Full Bench decision dated 27.4.2000, applicants in all the 4 OAs before us are entitled to include their 'S' grade of ARS or equivalent grade for computation in total length of service only for purpose of placement in the revised pay scale under the UGC pay package notified by ICAR on 9.3.89. It would not entitle them to include the said service for the purpose of promotion of Scientists Senior scale, Selection Grade, Senior Scientists under the Career Advancement Scheme notified on 28.10.91.

8. We as a Division Bench are bound absolutely by that Full Bench Decision and these OAs accordingly stand disposed of in terms of the same. No costs.
