Shri Justice Ashok Agarwal :


The case of applicants in the present O.A. is similar to the case of applicants in O.A. No.1394/96 decided by the Hyderabad Bench on 5.3.1998. In the circumstances, we proceed to dispose of the present O.A. by passing an order similar to the one passed in the aforesaid O.A.


2. Applicants are entitled to get their pay refixed in the scale of Rs.260-400 with effect from the dates of their entry into service. Applicants will carry the said pay scale till 1.1.1986 whereafter their pay scale will be governed by the recommendations of the 4th Central Pay Commission. Applicants will accordingly be entitled to payment of arrears based on the aforesaid refixation of pay scales. Payment in
