ORDER

S.R. Adige, VC(A):

Applicants impugn respondents' letter dated 6.12.94 (Annexure-A1) to the extent it lays down that such of the Computers/Data Entry Operators, Grade-A, who were graduates and had 6 years' service or more as on 11.9.89 or non-graduates with 12 years' service or more as on 11.9.89 would be placed in the scale of Rs. 1350-2200 (Data Entry Operator Grade-B) w.e.f. 11.9.89 and seek a declaration that applicants are entitled to be promoted as Data Entry Operator Grade-B (Rs. 1350-2200) in accordance with Finance Department's Memo dated 11.9.89 (Annexure-A3) with effect from the date they became entitled with all consequential benefits.

2. We have heard both parties.

3. The impugned order dated 6.12.94 (Annexure-A1) makes it clear that the impugned placements were a one time measure and all future recruitments/appointments,

as and when necessary, will be made in accordance with relevant recruitment rules to be framed as per the model recruitment rules laid down by DOP & T's guidelines dated 12.9.93 prescribed by Defence Ministry.

4. Our attention has been invited to the recruitment rules which have since been framed for the Data Entry Operator Grade-B in respondents Organisation and were notified on 17.2.99, a copy of which has been taken on record.

5. In the light of the above, the impugned placements are no longer operative, and placements in pay scale of Rs. 1350-2200 for DEO Grade-B ^{now} have to be made in accordance with aforesaid RRs notified on 17.2.99.

6. As these recruitment rules have replaced the impugned placements contained in respondents' letter dated 6.12.94 which were a one time measure and the RRs themselves have not been challenged, the OA warrants no interference and it is dismissed. No costs.
