1. Heard both the sides on the Review Applications seeking review of the Tribunal's impugned order, in the relevant OA, and for its placement before a Larger Bench for final adjudication of the matter.

2. This case involves disengagement of Home Guards. After the impugned order was passed, the Full Bench of Central Administrative Tribunal, Principal Bench in its order dated 25.11.99, has followed the Delhi High Court's order dated 25.6.99 in C.W.P. No. 4286/97 - Mansukh Lal Rawal & Others Vs. U.O.I. & Others and has separately adjudicated on cases involving disengagement of Home Guards, in terms of the aforesaid order of Delhi High Court dated 25.6.99.

3. It is the aforesaid order of the Delhi High Court dated 25.6.99 and the Full Bench's order dated 25.11.99 which now holds the field. Under the circumstances, the impugned orders do not require any review.

4. The Review Applications are dismissed.
