ORDER (ORAL)  
Hon'ble Sh. S.R. Adige, Vice-Chairman(A)

Heard the learned counsel for both sides on the above mentioned CPs/RAs/MA in the respective OAs alleging incorrect implementation and/or seeking review of the Tribunal's order in these OAs.

2. It is not denied that by the Hon'ble Supreme Court's order dated 08.09.2000 in Writ Petition(Civil) No. 433/98, there is a direction that there shall be no regularisation of parcel porters working at different railway stations notwithstanding any order of any Court, Tribunal or other authority.

3. In the light of the aforesaid order of the Hon'ble Supreme Court, these CPs/RAs/MA are disposed of and notices are discharged, with liberty granted to the parties that if the aforesaid orders of the Hon'ble Supreme Court dated 08.09.2000 are modified or vacated, it will be open to them to seek revival of these CPs/RAs/MA in accordance with law, if so advised.
