



We are informed that RA 55/93 in OA 1765/92 has already been disposed of. In the Tribunal's order dated 14.10.98 it is noted that Shri S.M. Garg, learned counsel for the applicants had submitted that the applicants have not contacted him for the last several months and he did not know whether they would like to pursue these cases or not. Thereafter on 30.10.98 we note that Shri R. Venkataramani, learned senior counsel had appeared for the applicants and today none has appeared for the applicants even on the second call.
