Applicants challenge a common order, namely No.4-31/92-PAT dated 31.5.1993 of the Government of India, Ministry of Telecommunications, informing them:


"...These cases do not constitute an anomaly and stepping up of pay cannot be allowed under the existing orders." (A-1, OA-229/94).


We are informed that this order has already been quashed by a bench of this Tribunal in OA-1121/95.
