ORDER (ORAL)

BY HON'BLE MR. S. R. ADIGE MEMBER (A).

We have heard Shri Naresh Kaushik counsel for the applicant and Shri M.M. Sudan counsel for the respondents.

2. Shri Sudan has invited our attention to the order dated 9.4.97 issued by the respondents pertaining to the Hon'ble Supreme Court's order dated 25.10.86 in SLP No. 26071/95 P. Subana and others Vs. P. Achutan & others and connected cases.

3. In the light of the orders dated 9.4.97 passed by the respondents Shri Kaushik upon instructions from his clients who were present in Court states that they are satisfied with the same and they do not want to pursue the OA.

4. In this connection, Shri Luthra proxy counsel for Shri Sant Lal states that some persons represented by Shri Sant Lal have sought impleadment in this OA. In the light of the fact that the applicants themselves do not intend to pursue the OA in view of the order dated 9.4.97, the question of impleadment of others in this OA does not arise. Shri Sant Lal's clients may pursue their remedies separately in accordance with law, if so advised.

5. The OA stands disposed of in terms of respondents' order dated 9.4.97. No costs.
