ORDER (ORAL)



Applicants seek a direction to fix their pay scale at par with the scale of NCT Teachers i.e. Rs. 5500-9000 and not in the scale of MCD Teachers i.e. Rs. 5000-8000. They also seek a direction to dispose of the OA in the light of the directions issued on 12.12.2000 in OA-1459/98 (Ved Pal Khare & Ors. Vs. Govt. of NCT Delhi).

2. We have heard applicants' counsel Sh. U. Srivastava who states that applicants are identically

placed as the applicants in OA-1459/98 (Ved Pal Khare & Ors. Vs. Govt. of NCT Delhi).

3. If these assertions are correct, we dispose of the present O.A. in terms of the Tribunal's order dated 12.12.2000 in OA-1459/98 (Ved Pal Khare & Ors.). *No costs*
