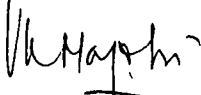
Shri Justice Ashok Agarwal :

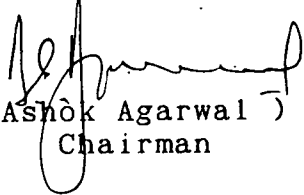
Present OA seeks regularisation of the services of applicants. They have all been engaged by the Secretary, Urdu Academy, respondent No.4 herein. Respondent No.4 is not amenable to the jurisdiction of this Tribunal. Present OA thus cannot be brought within the ambit and jurisdiction of this Tribunal by merely impleading respondents 1 to 3 on the strength of respondent No.4 receiving grants from respondents 1 to 3.

2. Applicants have been engaged by respondent No.4 and have been placed at the disposal of respondents 1 to 3 for promotion of Urdu language. They receive their salary not from respondents 1 to 3 but from respondent No.4. In the circumstances, we are constrained to hold that the Tribunal has no jurisdiction to entertain and try the OA even though applicants are serving in Schools which are being conducted by respondents 1 to 3.
