Justice V. Rajagopala Reddy:

Heard the counsel for the applicant and the
respondents.

2. The above two matters pertain to the Junior Specialists seeking continuance of their appointments on contract basis on a consolidated salary, in the hospitals under Govt. of NCT, Delhi, with all the benefits as were given to the Doctors in the Central Government until the duly selected Junior Specialists were appointed by the Govt. of NCT of Delhi, on regular basis. This matter is covered by the Sangeeta Narang & Others Vs. Delhi Administration, ATR-1988(1) CAT 556 and also in OA No.2746/99 and 2843/99 which this very Bench has disposed of on 19.10.2000, allowing the OAs.

3. Both the OAs are therefore allowed, in terms of the direction issued in the above OA No.2746/99 and OA No.2843/99, dated 19.10.2000. In the circumstances we do not order costs.
