## O R D E R (ORAL)

Shri Justice Ashok Agarwal :

Applicants in the present cases are similarly placed as the applicants in the case of Smt. Ramwati & Ors. v. Lt. Governor, NCT of Delhi & Ors., O.A. No.2237/1998 decided on 28.9.1999 and in the case of Mahabir Singh & Ors. v. Union of India & Ors., O.A. No.962/2000 decided on 12.9.2000. In the circumstances, present OAs are also liable to be disposed of by giving directions similar to the ones issued in the aforesaid OAs.

2. As has been done in the aforesaid cases, we take note of the statement made by and on behalf of the respondents that their proposal for creation of 286 posts of class IV employees including Sweepers is under active consideration of the Central Government, and that as and when the posts are sanctioned, and subject to the fulfilment of eligibility conditions under the relevant rules and instructions, they will take further action to regularise the applicants as Sweepers.

3. In view of the aforesaid statement, we dispose of the present OAs with a direction that the respondents should obtain the sanction for the aforesaid posts expeditiously and subject to fulfilment of the eligibility conditions by the applicants under the relevant rules and instructions, they shall take further action to regularise them as Sweepers. This action shall be taken as expeditiously

as possible and in any event within a period of four months from the date service of this order. There shall be no order as to costs.
