O R D E R (ORAL)

Shri Justice Ashok Agarwal :

In our judgment, present O.As. are wholly misconceived. Applicants had earlier approached this Tribunal by instituting O.A. No.673/99 and other connected matters. The same had been disposed of by a common order giving the following directions :

"(A) Applicants shall be allowed to continue in the present posts till regular candidates duly selected by DSSSB/or appropriate authority are available to replace the applicants.

(B) Those selected regularly shall first be posted in the existing vacant positions and only if enough vacant posts are not available, they should be posted against the posts held by ad hoc appointees. Replacement of the latter should be on the principle of 'last come first go'. Those so displaced should be accommodated in vacancies that may be existing in other districts.

(C) The ad hoc appointees shall be paid minimum pay in the pay scale of regular teachers plus DA in terms of law laid down by Hon'ble Supreme Court in the case of Daily Rated Casual Labourer Vs. UOI & Ors. (1988(1) SCC 122).

(D) No ad hoc appointee shall be replaced by any newly appointed ad hoc employees.

(E) Those of the applicants who have applied or may apply for regular selection, necessary relaxation in age shall be given to the extent of the period of service put in by them.

(F) There shall be no order as to costs."

2. Aforesaid order was carried to the High Court, whereby by an order passed on 20.12.1999 the aforesaid directions of the Tribunal contained in para (B) have been quashed. Rest of the directions have been maintained. SLP filed against the aforesaid order of the High Court at the instance of applicants has been rejected. After services of applicants ~~are~~ now being terminated on the basis of regular candidates being duly selected by the Delhi Subordinate Service Selection Board (DSSSB) and also through promotional channel, applicants have once again approached this Tribunal by instituting the present O.As. Interim orders have also been procured in most of the O.As. Parties are not ad idem as to whether the services of applicants have been terminated only after regular candidates have been appointed. On the one hand, Shri Srivastava, the learned counsel appearing for applicants, contends that their services have been terminated and the posts have been kept vacant, whereas this has been denied by Mrs. Ahlawat, the learned counsel appearing on behalf of respondents.

3. In our view, it would be unreasonable that posts are kept vacant merely in order to harm the applicants and thereby ~~also~~ prejudicing interests of respondents.

4. Present O.As., in the circumstances, are dismissed as being without merit. Interim orders earlier passed are vacated. It is clarified that

respondents will strictly adhere to the aforesaid directions passed by the Tribunal as modified by the High Court. There shall be no order as to costs.

5. In view of the present order, the contempt petitions which have been filed by and on behalf of applicants alleging breach of the interim orders, are also dismissed.
