

Learned counsel for both the parties submit that the facts and issues raised in the aforesaid two CPs are similar to those raised in CP 196/2003 in OA 2701/2000 which has been dismissed by order dated 16.7.2003. It is also relevant to note that in the Hon'ble Delhi High Court's order dated 7.7.2003 in the above referred two Contempt Petitions, a similar submission has been made by the learned counsel for the respondents/petitioners that in view of the pendency of the present Writ Petition, they will not press the CPs before the Tribunal.

2. In view of the above, CP 244/2003 and CP 245/2003 are dismissed, without issuing notice to the alleged contemners.
