ORDER


Hon'ble Shri S.P. Mukerji, V.C.-


In this application dated 11.8.1989 filed under section 19 of the Administrative Tribunals Act, the applicant, who retired as Office Superintendent in the office of Central Translation Bureau, has prayed that his representation dated 20.9.1988 should be directed to be disposed of by the respondents with all consequential benefits.
