ORDER (Oral)**Justice L. Narasimha Reddy, Chairman:**

The applicants state that they made a representation on 07.09.2020 to the respondents with a request to re-fix their pay in the pay scale of Rs. 13860+Grade Pay of Rs. 4600 in accordance with clause (A) (i) and (ii) of Rule 7 of the CCS (Revised Pay) Rules, 2008, and as per 4A of memorandum dated 30.08.2008, which was extended to similarly situated persons in the light of the order of the Tribunal in OA No. 98/2014. Their grievance is that no action has been taken on the representation.

2. We heard Mr. Ram NiwasBuri, learned counsel for the applicant and Mr. Dilbagh Singh, learned counsel for the respondents.

3. The applicants sought re-fixation of the salary in the revised pay of Rs. 13860 with Grade pay of Rs. 4600 which was extended to the similarly placed persons. It appears that the applicants did not have any grievance till recently and they made representation only in the light of the judgment rendered by this Tribunal in OA No. 98/2014 dated 04.11.2016. The question as to whether the applicants are entitled to be extended such a benefit, needs to be examined by the respondents. The fact that a subsequent pay commission i.e 7th CPC has also made

recommendations and they were implemented, shall also be taken into account. The delay is another aspect. Even if any revision is to be affected in such cases, it can be only prospective in operation.



4. We, therefore, dispose of the OA directing the respondents to pass order on the representation of the applicants within three months from the date of receipt of a copy of this order.

Pending MA No.2715/2020, shall stand disposed of.

There shall be no order as to costs.
