## **ORDER (ORAL)**

**Justice L. Narasimha Reddy, Chairman :-**

This OA is filed with a prayer to quash the minutes of the DPC held on 26.10.2017 and order dated 23.02.2018 for promotion to the post of Director in Central Secretariat Services. According to the applicants, they were not considered eligible by the said DPCs by stating that they did not have the five years of service, up to the relevant dates. Various other contentions are also urged.

2. In the counter affidavit, it is stated that subsequent to filing of the OA, another DPC was held on 18.09.2018 and the applicants were treated as eligible by counting their service in the grade of Deputy Secretary from 1<sup>st</sup> July of the select year and thereby, the substantial grievance of the applicants stood redressed.

3. Though the learned counsel for the applicants wanted to argue further. However, when it was indicated that the minutes of the DPC held on 18.09.2018 are not subject matter of this OA, he sought permission of the Tribunal to withdraw the OA with liberty to the



applicants to work out their remedies, if any grievance subsists.

4. We accord permission. The OA is dismissed as withdrawn, leaving it open to the applicants to pursue the remedies, if they are not satisfied with the promotions that were made subsequent to the filing of the OA.

Pending MA No.3346/2018 shall stand disposed of.

There shall be no order as to costs.
