### **ORDER (ORAL)**

**Justice L. Narasimha Reddy :**

OA No. 901/2016 was filed claiming certain reliefs in the context of fixation of pay scale of the applicant. It



is stated that during the pendency of the OA, substantial relief was granted and as regards the remaining, the applicant made a representation dated 11.09.2019. In view of this development, the applicant filed MA No. 27/2021 with a prayer to direct the respondents to consider the representation.

2. After hearing both the parties, we dispose of the O.A. directing that the respondents shall pass appropriate orders on the representation, if any, made by the applicant within a period of eight weeks from the date of receipt of a copy of this order. The O.A. and M.A. are ordered accordingly. There shall be no order as to costs.
