ORDER (ORAL)

Justice L. Narasimha Reddy :-

The applicants filed OA No.2873/2015 seeking certain reliefs. The OA was disposed of on 31.10.2019 quashing the order impugned in the OA and directing the respondents to pass fresh order on the representation submitted by the applicants within two months.
