**ORDER (ORAL)****Mr. Justice L. Narasimha Reddy:**

This batch of Review Applications is filed with a prayer to review a common order dated 10.02.2020 in O.A. No.3482/2019 and batch.

2. We heard Mr. Sanjoy Ghose, learned counsel for applicants and Mr. D S Mahendru, learned counsel for respondent, through video conferencing.
3. In the batch of O.As., the relief claimed by the applicants was for regularization of their services as Medical Officer (Ayurveda). The fact that the applicants approached the Hon'ble High Court of Delhi earlier by filing W.P. No.4787/2004 and batch and a relief of particular nature was granted, was taken note of. It was mentioned that the applicants were granted the relief in connection with their claim for regularization, no fresh adjudication can be undertaken.
4. Learned counsel for applicants is not able to point any factual mistake or error apparent on the face of record. The R.As. are accordingly rejected. There shall be no order as to costs.
