The present Original Application has been filed by the applicant seeking therein a direction to the respondents to consider his case for grant of employment on compassionate grounds.

2. At the very outset, Shri V.N. Holla, learned counsel representing the respondents, while drawing our attention towards the assertions made in the reply statement, submitted that meeting of the committee for appointment on compassionate grounds to consider the candidature of the applicant and all other eligible candidates was to take place in March, 2020. However, due to prevalent situation because of COVID-19 pandemic, the said meeting could not take place even upto today. Shri V.N. Holla further submitted that the respondents are now in the process of convening the meeting of the committee for appointment on compassionate grounds and they will be able to complete the whole process within a period of three months from today.

3. In view of the above statement made by Shri V.N. Holla, learned counsel representing the respondents, the Original Application is disposed of with a direction to respondents to convene the meeting of the committee for appointment on compassionate grounds and consider the applicant's case within a period of three months from the date of receipt of a certified copy of this order.

4. The OA stands disposed of in the above terms. However, there shall be no orders so as to costs.
