**O R D E R (ORAL)**

M.A.No.060/810/2020 is allowed and the applicants are permitted to file a joint Original Application (OA).

2. The applicants have approached this Tribunal, inter-alia, for issuance of direction to the respondents to implement the letter dated 4.2.1969 of the State of Punjab and decision dated 26.4.2018 in a bunch of petitions including CWP No.7213 of 2013 (**TARLOK CHAND & OTHERS VS. STATE OF PUNJAB ETC.**) and IDR No. 568 of 1988 (**ITI ELECTRICAL WORKERS ASSOCIATION (REGD.) VS. THE CHIEF ENGINEER, U.T. CHANDIGARH,** decided on 16.4.1990 (Annexure A-7), for revision of pay scales etc. for which they have already submitted various legal notices, Annexures A-9 to A-12 which have remained unanswered.

3. Learned counsel for the applicants submitted that the applicants would be satisfied if the O.A. is disposed of by issuance of direction to the respondents to consider and take a decision on the pending legal notices served on behalf of the applicants in the light



of judicial pronouncements on the issue relied upon by them, within some time bound manner.

4. In the wake of the aforesaid factual scenario, I dispose of this O.A. with a direction to the competent authority amongst the respondents to consider and decide the indicated legal notices, Annexure A-9 to A-12, by taking into consideration the judicial pronouncements relied upon by the applicants within a period of three months from the date of receipt of a copy of this order. If the applicants are found to be similarly situated, they be extended due benefits else a speaking and reasoned order be passed and conveyed to them in writing within indicated time. The disposal of the O.A. may not be construed to mean expression of any opinion on the merits of the case. No costs.
