- 2. MA 213/2020 is filed seeking the corrections of the typographical errors in the final order dt. 03.06.2020 in OA 904/2016 as follows:-
 - "i. To correct the penultimate sentence in para 3 of the order dt. 03.06.2020 in the OA as "The applicant completed 30 years of regular service on 03.12.2003" instead of "The applicant completed 30 years of regular service on 03.12.2006".
 - ii.
