These OAs having been heard together on 19<sup>th</sup> August, 2020, the Tribunal delivered the following common order on 10.09.2020:

## **ORDER**

### **P.Madhavan, Judicial Member**

OA No.287 of 2020 and OA No.906 of 2019 are filed by the same applicant Smt. Thasleema K.P., who is presently posted at Coimbatore Office of National Sample Survey Office. In OA No.287/2020, the applicant seeks a declaration that she is entitled to be posted at Thrissur in preference to the 9<sup>th</sup> respondent. In OA No.906 of 2019, she seeks a declaration that she is entitled to get a transfer to Kozhikode. In OA No.898 of 2019, the applicant - Smt.Athira Sadhu - who is similarly posted at Coimbatore, seeks a declaration that she is entitled to be posted at Ernakulam in preference to respondents 6 & 7. In OA No.928 of 2019, the applicant – Smt. Alby Annie George, similarly posted at Coimbatore, seeks a declaration that she is entitled to be posted at Kochi or at Thrissur.

2. When the matter came up for consideration, the respondents had raised a question of jurisdiction and it was heard as preliminary issue.

3. The applicants in these cases are working as Senior Statistical Officers at the Coimbatore office of National Sample Survey, in Tamil Nadu State. The applicants in these cases had sought for a transfer to Trissur, Ernakulam and Kozhikode offices. But the respondents had not considered their requests in accordance with the transfer guidelines and had arbitrarily granted transfer to their juniors and issued impugned order dated 4.12.2019 (Annexure A5) in OA 928/2019.

4. According to them, the impugned order is patently illegal and arbitrary in nature. The applicants had arrayed the private respondents who got transfer to the places where the applicants sought transfer and this Tribunal on initial hearing had stayed the transfer of private respondents in these cases until further orders.

5. The private respondents had filed MAs for vacating the interim order and R1 to R5 (official respondents) had filed a detailed reply. The respondents mainly

oppose the OAs on grounds of jurisdiction and hence the question of jurisdiction is considered as preliminary point.

**6. The point for consideration is whether this Tribunal has jurisdiction in entertaining these OAs?**

7. We had perused the pleadings, documents and heard the arguments put forward by both sides. Before going to discussion, it will be worthy if we go to Rule 6 of CAT (Procedure) Rules:

*6. Place of filing application: (1) An application shall ordinarily be filed by an applicant with the Registrar of the Bench within whose jurisdiction -*

- (i) the applicant is posted for the time being, or*
- (ii) the cause of action, wholly or in part, has arisen:*

*Provided that with the leave of the Chairman the application may be filed with the Registrar of the Principal Bench and subject to the orders under section 25, such application shall be heard and disposed of by the Bench which has jurisdiction over the matter.*

*(2) Notwithstanding anything contained in sub-rule (1), a person who has ceased to be in service by reason of retirement, dismissal or termination of service may at his option file an application with the Registrar of the Bench within whose jurisdiction such person is ordinarily residing at the time of filing of the application.*

8. Learned counsel appearing for the applicants would contend that a part of the cause of action had fallen at Thrissur, Ernakulam and Kozhikode since the applicants were denied a transfer to those places and Annexure A5 order was issued. On the other hand, the counsels appearing on the side of official respondents and private respondents would contend that the cause of action had arisen at Coimbatore where the applicants are working and these OAs ought to have been filed before the Chennai Bench of the Tribunal. They mainly rely upon the judgment rendered by the Hon'ble High Court of Kerala in **Registrar, Indian Maritime University, Chennai vs. Dr.K.G. Viswanathan & another**, reported in 2014 (4) KHC 451 (FB) and the order of Principal Bench in **Mukesh Kumar**

**Meena vs. Union of India & 20 Others** in OA 2833/2010 dated 15.3.2011.

9. We accordingly considered the rival contentions put forward by both sides. Both sides admit that the applicants are at present working in Tamil Nadu. Learned counsel for the applicants would contend that the applicants had requested for a transfer to Thrissur, Ernakulam & Kozhikode and the respondents had not granted the same and posted some other officers in these vacancies. On a perusal of the pleadings, what we find is that the applicants in these OAs had requested for transfer to various stations in Kerala and the respondents had not granted them a transfer. So the main cause of action is denial of transfer to the applicants who are now working at Coimbatore. So the cause of action arose at Coimbatore, in Tamil Nadu State and not in Kerala. As per Rule 6 (1)(i), the applicants ought to have filed these OAs in the CAT Bench of the State where they are working. We are not impressed by the arguments of the counsel for the applicants that since the applicants had sought a transfer to Thrissur, Ernakulam and Kozhikode, this Tribunal will get jurisdiction to decide the matter. Since the applicants are working at Coimbatore, showing their permanent residence in Kerala cannot confer any jurisdiction. The existence of vacancies in Kerala has no nexus with the cause of action in this case. The bundle of facts which constitute the cause of action in this case is denial of a request transfer given by the applicants from the office at Coimbatore. There cannot be any part cause of action in these cases. The request for getting a posting at Thrissur or Ernakulam or Kozhikode does not have a close nexus to the main cause of action in these cases. The impugned transfer order was issued by the Deputy Director (SSS), New Delhi. So there is no merit in the contentions raised by the applicants. No integral part of cause of action has arisen in this State.

**10.** So we find that there is no jurisdiction for this Tribunal to entertain these OAs and these are liable to be dismissed. **The OAs are accordingly dismissed. The Registry will keep a copy of the OAs and return the copy of documents produced for approaching the jurisdictional bench if they desire so. The interim order of stay passed in these OAs will stand vacated forthwith.**
