This application having been heard on 19.01.2021, the Tribunal on the
same day delivered the following:

Hon'ble Mr. P. Madhavan, Judicial Member –

Heard Advocate Shri V.T. Madhavan Unni, learned counsel appearing
for the applicant and the learned counsel appearing for the respondents.

2. The applicant is working as Assistant Administrative Officer at Kidu. He had made a request for transferring him to the Headquarters at Kudlu, Kasaragod. There was a vacancy of Assistant Administrative Officer at Kasaragod at that time. However, the respondents have not considered his request and therefore, he made Annexure A10 representation which is pending consideration with the respondents. Aggrieved the applicant has filed this OA seeking the following reliefs:

“(a) To direct the respondent No. 1 and 2 to convene the transfer committee at the earliest and consider Annexure A10 representation strictly as per the ICAR guidelines.

(b) To direct the respondents to transfer and post the applicant at Headquarters at Kudlu, Kasaragod, as Assistant Administrative Officer.

(c) Grant any other further relief or order as this Hon'ble Tribunal may deem fit and proper to meet the ends of justice.

e) Grant the costs of this Original Application.”

3. When the matter was taken up for consideration, learned counsel for the applicant submitted that he has given a representation to the competent authority as Annexure A10 dated 7.2.2020 and he will be satisfied if a direction is issued to the competent authority to consider the same in accordance with the rules and regulations within a time frame.

4. Learned counsel for the respondents have no objection in considering the representation filed by the applicant.

5. **In view of the limited relief sought by the applicant, without going into the merits of the case, we direct the competent authority to consider and dispose of Annexure A10 representation dated 7.2.2020 filed by the**

applicant on the basis of the relevant rules and orders and pass a speaking order within a period of three months from the date of receipt of a copy of this order.

6. The Original Application is disposed of as above at the admission stage itself. No order as to costs.
