2. The Original Application is filed seeking the following reliefs:

*" (i). to call for the records relating to Annexure A-1 to A-10 and to declare that the applicants are eligible and entitled to count their service from 2011 onwards at least notionally for the purpose of taking part in further Departmental Examinations for promotions;*

*(ii). to direct the respondents to count the service of the applicants as MTS from the vacancy year of 2011, as regular service for the purpose of making them eligible to take part in the examination pursuant to A-9 notification;*

*(iii) to direct the respondents to reckon the service of the applicants as MTS with effect from 2011 notionally as qualifying service for the purpose of taking part in Departmental Examinations for further promotion to Postman, PA/SA etc.;*

*(iv) to pass such other orders or directions as deemed just, fit and necessary in the facts and circumstances of the case*

*and*

*(v) To award costs of this proceedings.*

3. When the matter was taken up today for hearing on M.A 180/315/2020, the learned counsel for the applicant submits that the Original Application may be permitted to be withdrawn. Permission is granted and the M.A is allowed. The Original Application is dismissed as withdrawn. No costs.
