Heard Mr. T. Koteswara Rao, learned counsel for the applicant and Mrs. K. Rajitha, learned Senior Central Govt., Standing Counsel for Respondents.

2. This matter has been listed by giving Diary Number because the Registry has pointed out that the applicants have not exhausted the remedies available under Section 20 of Administrative Tribunals Act, 1985, i.e. the applicants have not ventilated their grievance before the appropriate Departmental Authorities.

3. During the course of hearing, learned counsel for the applicant fairly submitted that the applicants were discriminated, as per the well settled position of law, there cannot be a class within the class. Therefore instead of approaching the Departmental Authorities, they have approached this Court. But we are at a loss to appreciate this position because the Administrative Tribunal's Act provided that the aggrieved parties should approach the appropriate Departmental Authorities in case he/she feels aggrieved and thereafter only has to approach this Tribunal.

4. Mr. T. Koteswara Rao, learned counsel for the applicants submitted that following the orders of our Principal Bench as well as Kolkata Bench,

some employees have approached this Tribunal in OA No.122/2015, disposed of on 18.02.2016 and applicants in that OA got the benefit.

5. The present applicants claiming the same benefits have approached this Tribunal. At the cost of repetition, we would like to state that the applicants have not approached the appropriate Departmental Authorities. Therefore, in our considered view, this case is not maintainable in the instant form.

6. However, on consideration of the submissions of the counsel on both sides, we dispose of this matter by directing the applicants to make an individual comprehensive representations to the 3<sup>rd</sup> Respondent enclosing the copies of judgments of different courts clearly explaining why they feel discrimination within a period of two weeks from the date of receipt of a copy of this order and in case any such representations preferred individually by the applicants, then the same may be considered keeping in mind the Rules as well as the well settled position of law as stated above and the result be communicated within a period of four weeks to the applicants individually by way of reasoned and speaking order.

7. Although we have not taken into consideration the merits / points raised in the present OA, we hope that, if the applicant(s) are found similarly situated to the applicants in OA No.122/2015, then necessary steps be taken by the Respondents to grant the same benefit to the applicant(s) within a further period of three months.

8. The applicants are also directed to annex copy of this order along with their representation to be preferred.

9. With the above observations and direction, the office objection is over ruled. MA seeking for joining the applicants together is allowed subject to payment of requisite fee. Office to Register the OASR.

10. Original Application is disposed of accordingly. No order as to costs.
