ORDER (Oral)

Learned counsel for the official respondents Nos.1 to 4 has filed reply wherein it has been specifically submitted in Para 2.13 which reads as under:-

“2.13 That, it is respectfully submitted here considering the interim order passed by this honourable Tribunal in O.A. No.351/20 and OA No.386/20 the competent authority has decided to cancel the list of nominated employees for promotional course/MLD for the post of Loco Pilot Shunting-II/Loco Pilot Goods (Level-6) and issued fresh list of 100 employees for promotional course/MLD by order dated 06.08.2020 Annexure R/6 as per the seniority list. In this view of the matter, the original Application filed by the applicant has become infructuous now there is no substance therefore the same deserve to be dismissed.”

2. Learned counsel for the private respondents Nos.5 to 10 has filed their detailed reply. It has been submitted by the private respondents Nos.5 to 10 that the official respondents have issued

the order Annexure R/6 in pursuance to the interim order passed by this Tribunal.

3. We have considered the matter and in view of the reply filed by the official respondents Nos.1 to 4 in Para 2.13, the relief claimed for by the applicant has become infructuous.



4. Needless to say that private respondents Nos.5 to 10 have a separate cause of action to challenge the action of the respondent-department.

5. With these observations this Original Application is disposed of as infructuous.
