ORDER

By Ramesh Singh Thakur, JM-

This Review Application has been filed by the applicants (respondents Nos.5 to 10 in O.A.) to review the order dated 04.09.2020 and also order dated 04.08.2020 passed by this Tribunal in Original Application No.200/00386/2020. Along with this Review Application, the applicants have filed M.A. No.200/0506/2020 for grant of stay.

2. The grounds taken by the applicants in this Review Application are that the Tribunal has failed to appreciate that so called interim order dated 04.08.2020 which was passed behind the back of the present applicants, was of final nature, in as much as, there was positive direction against official respondents to consider the case of

respondents (applicants in O.A.). Over and above, the present applicants (private respondents in O.A.) while implementing such interim order would not lead the Original application as infructuous. Thus, there is an error apparent on the face of record while passing the order dated 04.09.2020.



3. We have heard the learned counsel for the private respondents and we have noticed that in view of Para 2.13 of the reply, the O.A. is infructuous. As the Original Application has been dismissed as having become infructuous, so any interim order pending along with the O.A. merges with final order in the main O.A.

4. We have also considered the reply filed by the private respondents in O.A. The order dated 04.09.2020 passed by this Tribunal is well reasoned, not only this, the official respondents in O.A. have considered the claim of the respondents (applicants in O.A.), as the present applicants in review application and the respondent-department had filed the detailed order and considered the case of the applicants.

5. The Tribunal can review its own order/decision only if;

- (a) if there is mistake or apparent error;
- (b) the discovery of new or important fact which could not be produced before the order is pronounced.



6. In view of the above, since there is no mistake/apparent error nor any new facts have been brought to our notice, we do not find any reasons and grounds for reviewing the order dated 04.09.2020 passed by this Tribunal in O.A. No.200/386/2020.

7. Resultantly, this Review Application is dismissed at circulation stage itself. Accordingly, the M.A. filed by the applicants stand dismissed.
