2. In the present OA filed under Section 19 of the Administrative  
Tribunals Act, 1985, the applicant has challenged the action of the  
respondents in denying him an opportunity to compete for his



appointment in the Railways against Employment Notification No.RRC/WR/02/2018 (Sports quota) dated 06.10.2018 to the posts in Level-2/3 by Pay Matrix Rs.19,900-69,100/-.

3. In view of the interim order passed by this Tribunal, the applicant was allowed by the respondents to participate in the aforesaid selection process. When the matter was taken up today for hearing, the respondents through their learned counsel have produced the record of the selection process for the aforesaid posts in a sealed cover. We have perused the same and we found that the applicant has not been recommended for the aforesaid post in the said selection process.

4. In view of the aforesaid, the matter remains only of academic purposes and the same is disposed off as having become infructuous. No costs.
