Advocate Shri A.I. Bhatkar for the applicants.

2. Heard on Admission

3. MA No.14/2021 has been filed by the applicants for Joint Petition. The same is allowed since the applicants are similarly placed.

4. The present OA has been filed by the applicants under Section 19 of the Administrative Tribunals Act, 1985 seeking the following reliefs:-

*"8(a) This Hon'ble Tribunal will be graciously pleased to call for the records pertaining to the grant of Hospital Patient Care Allowance/Patient Care Allowance to the categories of the applicants and after going through the same hold and declare that the applicants are eligible and entitled to receive the Hospital Patient Care Allowance/Patient Care Allowance.*

*(b) This Hon'ble Tribunal will be graciously pleased to hold and declare that the applicants are entitled for Hospital Patient care Allowance/Patient Care Allowance with effect from the date they are working in the Naval Hospital (INHS ASVINI).*

*(c) This Hon'ble Tribunal will be graciously pleased to grant all the consequential benefits arising out of grant of the aforementioned relief.*

*(d) This Hon'ble Tribunal will be graciously pleased to pass such other and further orders as deemed fit in the facts and circumstances of the case.*

*(e) Cost of this application be awarded to the applicants."*

5. Learned counsel for the applicants states that applicant Nos.1 to 16 are working as MTS (Chowkidar) in the Naval Hospital (INHS ASVINI) under respondent No.4 from the date of their appointment. They are discharging the duties and responsibilities of Chowkidar and are required to attend and remain in contact with the patients. The



applicant No.17 also worked under respondent No.4 till the date of his retirement on 30.06.2020. The applicant No.18 also worked as MTS with respondent No.4 till 09.02.2020 when he was promoted as LDC. It is stated that the Ministry of Health and Family Welfare vide its order dated 10.07.1990 granted the benefit of Hospital Patient Care Allowance (HPCA)/Patient Care Allowance (PCA) to Group 'C' & 'D' employees working under CGHS. Further, the Ministry of Defence vide OM dated 08.11.1995 made certain categories of Group 'C' & 'D' employees eligible to receive HPCA/PCA. However, vide order dated 17.11.2005, respondent No.1 excluded certain categories of employees which were earlier included in the order dated 08.11.1995. Consequently, Group 'C' & 'D' employees working in the Military Hospital, Kirkee, Pune approached this Tribunal vide OA No.764/2004 challenging the decision of respondent No.1 dated 17.11.2005 as well as for enhancement of HPCA/PCA and arrears at revised rates. This OA was allowed vide order dated 29.02.2008 and is Annexure A-2. The applicants have also stated that identical OA Nos.393/2007, 228/2008 & 272/2019 were allowed by this Tribunal. The respondents had approached the Hon'ble High Court vide Writ Petitions against the order of this Tribunal in OA Nos.393/2007 & 228/2008, which were dismissed by the Hon'ble Bombay High Court. Learned counsel for the applicants has submitted that the



present applicants are also similarly placed and are entitled to receive HPCA/PCA.

6. It is submitted that the applicants approached the respondents vide representation dated 16.01.2019 (Annex A-9). However, no response has been received by the applicants.

7. In the facts and circumstances of the case, it would be appropriate to direct the respondents to consider the case of the applicants for their entitlement to HPCA/PCA claim in the light of the judgments referred above and dispose of their representation dated 16.01.2019 vide reasoned and speaking order. Ordered accordingly. The respondents are directed to dispose of the representation within a period of six weeks from the date of receipt of certified copy of the order and to communicate the same to the applicants within one week thereafter.

8. With these directions, the Original Application stands disposed of at the admission stage itself. No order as to costs.
