ORAL ORDER

Present:

Advocate Shri Joe D'Souza for the applicants.

2. Heard him. He submits that other 67 Group 'D' employees similarly situated with the applicants have been absorbed on

redeployment as Announcers Ex-Cadre Staff in Commercial Department of Central Railway, Mumbai. But the applicants have not been similarly absorbed in the Commercial Department by Sr. DRM, Central Railway, Pune. On their grievance, they have submitted a representation on 17.10.2019 to DRM, Central Railway, Pune but it has not yet been decided by him. He further submits that the applicants would be satisfied if this OA is disposed of directing the respondents to consider their representation dated 17.10.2019 to absorb them as Announcers Ex-Cadre Staff in Commercial Department on par with 67 Group 'D' employees absorbed as per order of 03.06.2019 issued by office of Divisional Personnel Officer, Mumbai Central, CST.

3. In view of these submissions, this OA is disposed of at admission stage with direction to the respondent No.2 (Additional Divisional Railway Manager, Central Railway, Pune Division, Pune) to consider the representation of the applicants dated 17.10.2019 for their absorption as Announcers Ex-Cadre Staff in Commercial Department similar to those 67 employees absorbed on redeployment as Announcers Ex-Cadre Staff by DRM Office, Mumbai Central, CST by order of 03.06.2019 as per the applicable relevant rules and instructions on the subject in two months from the date of receipt of certified copy of this order and thereafter to communicate the order of the applicants.

4. With this the OA stands disposed of.
