

whether there is an order of his transfer, he admitted that there is no such order of his own transfer but after the transfer of Shri Meshram by this order of 31.12.2020 he is not clear as to which employee would work under his supervision, etc.

4. It was explained to him that an OA can be filed only when there is any specific decision or order of the respondents adversely affecting the applicant and after his representation against such order has been decided by the respondents. Since there is no specific order of transfer of the applicant, he seems confused and has unnecessarily indulged in this wasteful litigation. When it was explained to him, he seeks permission to withdraw the present OA.

5. Therefore, this OA is dismissed as withdrawn.
