O R D E R (ORAL)

Justice L. Narasimha Reddy:

The applicants are aspirants for employment to the post of Statistical Assistant. Recently steps were initiated to conduct an examination for selection for the post, through SRO No.339, dated 09.08.2018. The State Public Service Commission was entrusted with the task of conducting the examination and selection. According to the applicants, it is only the department that is competent to conduct the examination.

2. They contend that the syllabus has not been updated. With this grievance, they filed the OA. It was admitted and while declining the interim order, it was observed that any examination, which is held, would be subject to the outcome of the OA.

3. Mr.Bhat Fayaz Ahmad, the learned counsel for the Applicant, submits that recently the Lieutenant Governor issued SO No.312, dated 13.10.2020 directing revision of the syllabus.

4. In view of the above, the grievance of the applicant stands redressed to a substantial extent.

5. We, therefore, dispose of this OA directing that the examination for selection to the post of Statistical Assistant, shall be in accordance with the syllabus as directed in SO No.312, dated 13.10.2020.

6. The MA.No.225/2020 stands disposed of. There shall be no orders as to costs.
