O R D E R (ORAL)

Dr. Bhagwan Sahai, Member (A):

Mr. Mukhtar Ahmad Mir and 44 other applicants have filed this O.A. on 15.06.2020. They seek setting aside of letter dated 29.05.2020 (paragraph 2) for requisitioning fresh cash for payment of wages to only 40 need based casual labourers working in the respondent-department, which did not include all the applicants herein. They further seek direction to the respondents to pay all the outstanding due wages to the applicants continuously without any delay.

2. The applicants have brought to our notice their representation through legal notice dated 08.06.2020 submitted to Superintending Engineer, Generation Circle III, PDC Bemina requesting for requisitioning higher salary / wages

to all the casual labourers, including them, till all the casual labourers are being verified. This representation / legal notice of the applicants has still not been decided by the respondents.

3. We have heard Mr. Lone Altaf, applicants' counsel and Mr. Amit Gupta, AAG for respondents today.

4. After considering the averments of the applicants in the O.A. and rival submissions of the respective counsels, we think it appropriate to dispose of this O.A. at this stage with a direction to the respondents to consider and decide the pending representation / legal notice of 45 applicants dated 08.06.2020 for making of payment of wages due to them. The respondents should decide this representation / legal notice by passing a well-reasoned and speaking order within seven days from the date of receipt of a copy of this order and communicate it to the applicants within one week thereafter.

5. The O.A. is accordingly disposed of. No costs.
