ORDER

Rakesh Sagar Jain, Member (J)

Shri Mohd. Altaf Ganie and 07 other applicants have filed this OA on 14.09.2020 seeking direction to respondents to place them in pay scale of Rs.220-430 (pre-revised) as revised from time to time in light of the J&K High Court judgment dated 11.10.2012. They contend that the respondents have wrongly placed them in the pay scale of Rs.200-320 (pre-revised) instead of the scale of Rs.220-430 although they are entitled for it.

2. Heard Shri Anil Khajuria, learned counsel for the applicants and Shri Sudesh Magotra, DAG for the respondents.

3. The applicants' counsel submits that in view of the above mentioned High Court order and dismissal of challenge to it by the Apex Court and order of the Tribunal dated 23.06.2020 in OA 061/83/2020, they have submitted a detailed

representation to respondent no.3 on 25.05.2020. He also submits that the applicants would be satisfied if this OA is disposed of at this stage itself with direction to the respondents to decide their representation dated 25.05.2020 within a specified period of time.

4. In view of the above submission of the applicants, we dispose of this OA at the admission stage itself with direction to the respondents to decide their representation dated 25.05.2020 as per provisions of relevant rules and case laws. This exercise should be completed by the respondents with 60 days from the date of receipt of a copy of this order, by passing a well reasoned order and communicate it to the applicants. OA is disposed of. No costs.
