Learned counsel for the applicants submits that the applicants have filed present OA seeking issuance of direction to the respondents to fix the seniority and frame the seniority list of the Forest Protection Force Guards of District Kupwara at District Level and to effect the promotions of the applicants to the next higher post of Deputy Inspectors at district level and further to implement the J&K Civil Services Decentralization and Recruitment Rules, 2010 while framing the seniority list.

2. During course of arguments, learned counsel for the applicant submits that the applicants would be satisfied if a direction is given to the respondents to consider and decide the representation of the applicants dated 26.06.2018 (Annex. A/N) by passing a reasoned and speaking order within a stipulated period of time.

3. In view of the submissions made by learned counsel for the applicant seeking limited direction, the O.A. is disposed of with a direction to the respondents to decide the representation of the applicant dated 26.06.2018 (Annex. A/N) by passing a reasoned and speaking order in accordance with the relevant rules and intimate the same to the applicants, within a period of two months from the date of receipt of a certified copy of this order.

4. It is made clear that we have not expressed any opinion on merits of the case while disposing of the present OA.
