The applicant claims the relief of stepping up of his salary in terms of FR 22 under Revised Pay Rules (RPR), 2016.

2. We heard the applicant who argued the case in person.
3. Even from the averments in the OA, it is evident that the representation made by him in this behalf was rejected by the respondents through a detailed order dated 30.01.2019. Further, he felt aggrieved by that and made another representation, and that was also rejected on 13.02.2020. For reasons best known to him, the applicant did not challenge either of the orders. Therefore, we find it difficult to entertain the OA.
4. Accordingly, the OA is dismissed. However, we leave it open to the applicant to file a fresh OA challenging the orders dated 30.01.2019 and 13.02.2020. There shall be no order as to costs.
