1. Case of applicant Balram Sharma is that the respondents did not put up the case of the applicant before the DPC, even though the complaint against him was consigned to record as per communication dated 18.02.2020 (Annex A-4). Hence this O.A., seeking a direction to the respondents to promote him to the post of Inspector from the date his juniors (private respondents) have been promoted, with all consequential benefits.
2. During the course of preliminary arguments, learned counsel for applicant submitted that the O.A. can be disposed by directing the respondents to consider the applicant's representation dated 16.5.2020 (Annex A-5) regarding opening of the sealed cover and promoting him since the complaint against him has been consigned to record.
3. We have heard and considered the arguments of learned counsel for applicant and Mr. Amit Gupta, learned AAG for respondents and gone through the material on record.
4. Looking to the arguments of the learned counsel for the applicant, in our opinion, ends of justice will be met in this



case, if the O.A. is disposed of with a direction to the respondents to consider and decide the applicant's representation dated 16.05.2020 (Annex A-5) .

5. Accordingly, O.A. is disposed with the direction to the respondents to consider under relevant rules and dispose of the indicated representation of the applicant by way of reasoned and speaking order within the period of 3 weeks from the receipt of certified copy of this Order with intimation to the applicant. The O.A. is accordingly disposed of. We have not expressed any opinion on the merits of the case. There shall, however, be no order as to costs.
