**ORDER (ORAL)**

The instant O.A. has been filed by the applicants seeking direction to the respondents for payment of unpaid wages of applicants for the periods they have actually performed their duties. It is noticed that in this regard a letter dated 24.07.2020 has been issued by the Government of Jammu and Kashmir, Office of the Regional Transport Officer, Transport Nagar, Jammu to release the funds to enable the office to clear the long pending dues of the consolidated workers who are regularly performing their official duties in this office with dedication but the same has not been done.

During the course of arguments, learned counsel for the applicant submitted that he will be satisfied if a direction is given to



respondents/competent authority to pay the pending dues of applicants or to pass a reasoned and speaking order as per Rule within a stipulated period of time.

2. Looking to the limited prayer made by learned counsel for the applicant, O.A is disposed of at the admission stage itself with a direction to the respondents/competent authority to consider and pay the pending dues of applicants within one month from the date of receipt of copy of this order. In case, none payment, a reasoned and speaking order may be passed within one month from today. It is made clear that we have not entered into the merits of the case. No costs.
