## O R D E R

### [O R A L]

#### **Delivered by Hon'ble Mr. Anand Mathur, Member (A): -**

Learned counsel for the applicants submits that the applicants are working in the PHE Department (now Jal Shakti Department) as casual labourers. As per order no. No. 01-F of 2017 issued by the Government of Jammu and Kashmir all Imprest Workers of PHE Department were required to be registered on the NIC Portal. The grievance of the applicants is that their names have not been registered on the NIC Portal.

2. Learned counsel for the applicants further submits that the applicants will be satisfied, in case, a direction is issued to the respondents to upload the names of the applicants in NIC portal who are the casual labourers of Jal

Shakti Department (PHE) and release all the service benefits at par with the similarly situated workers whose names were uploaded in the NIC Portal.



3. In view of the limited prayer made by the learned counsel for the applicants, the O.A. is disposed of with direction to the respondents to consider uploading the names of the applicants in NIC Portal and release all the service benefits at par with similarly situated workers whose names were uploaded in the NIC Portal as per rules and taking into account the letter dated 24.04.2019 passed by the Chief Engineer, PHE Department.

4. It is made clear that we have not entered into the merits of the case. No order as to cost.
