JUDGEMENT (ORAL)

Hon'ble Shri S.R. Adige, Member (A)

In this O.A. Shri K.C. Papani & 37 Others, all Casual Artists working in Doordarshan / have prayed for a direction to the respondents to regularise them in service together with the grant of consequential benefits.

2. None appeared for the applicants when the case was called out although we waited ~~for~~ till 3 p.m. today. We also note that when the case had come up for hearing on 20.07.94, none appeared for the applicant although the case was called out twice. Shri M.L. Verma appeared for the respondents, and as this is a very old case and was listed at Sr No.3 of the Regular Cases for hearing today, we thought it fit to dispose it of after hearing Shri Verma and examining the materials on record. Shri Verma has invited our attention to the affidavit dated 18.07.94 filed by the Respondents, enclosing a copy of the approved Scheme and containing guidelines regarding regularisation of casual artists working in Doordarshan. In the affidavit it has been stated

that the present O.A. is already covered under the directions of the Tribunal given in O.A. No.563/86 Shri Anil Kumar Mathur Vs. Union of India, and the Scheme framed thereunder, and the respondents have already considered the cases of the applicants as per the scheme. Thus, applicants who are eligible as per scheme, are being regularised as per their seniority in the Select Panel, against the available vacancies, and the remaining eligible candidates would be regularised in Doordarshan against the future vacancies.

3. In the facts and circumstances of the case and having regard to the decision of the Tribunal in Anil Kumar Mathur's case (Supra), we direct the respondents to consider the case of the applicants for regularisation in terms of the approved Scheme within a period of three months, if not already done, by passing a speaking order. Thereafter, if any grievance remains, the applicant may take such action as advised. No costs.
