ORDER (JAL)

(Hon'ble Smt. Lakshmi Swaminathan, Member (J))

In this application, the petitioners have sought certain benefits which according to them have accrued as a result of the judgments of this Tribunal in JA 1793/88, JA 1794/88 and JA 1796/88 which were disposed of by a common order dated 2.3.90.

2. We have heard both the learned counsel and perused the records.

3. Shri R.S. Rawat, learned counsel for the applicants has admitted that the applicants as well as the respondents in the present case are the same parties as were in JA 1794/88. It is also noticed that the main reliefs sought in this O.A. had already been granted by

the Tribunal's order dated 2.3.90 which is also not denied by the learned counsel. Shri V.S.R. Krishna, learned counsel for the respondents submits that as regards the relief claimed in para 8(iv) i.e. for payment of arrears of salary and allowances, this prayer had also been included in the relief granted in para 11(ii) of the judgment/order dated 2.3.90. Learned counsel for the respondents, therefore, submits that as the present J.A. is barred by the principles of resjudicata it may be dismissed on this ground.

3. The above narration of facts clearly shows that the reliefs claimed in this J.A. had already been granted in the order of the Tribunal in JA 1794/88 dated 2.3.90 excepting the prayer for arrears of salary and allowances. As regards, this prayer, nothing has been shown by the applicants as to why this could not have been prayed for in the earlier J.A. We are, therefore, of the view that this J.A. is clearly barred by the principles of constructive ~~of~~ resjudicata.

4. In the result, this JA is dismissed. No order as to costs.
